


SPECIFICATION NOTE:

- 1. Output can provide up to peak load when the power supply starts up. Continuous staying in more than rated load is not allowed.
- 2. At factory, in 60% rated load condition, each output is checked to be within voltage accuracy.
- 3. Line regulation is defined by changing ±10% of input voltage from nominal line at rated load.
